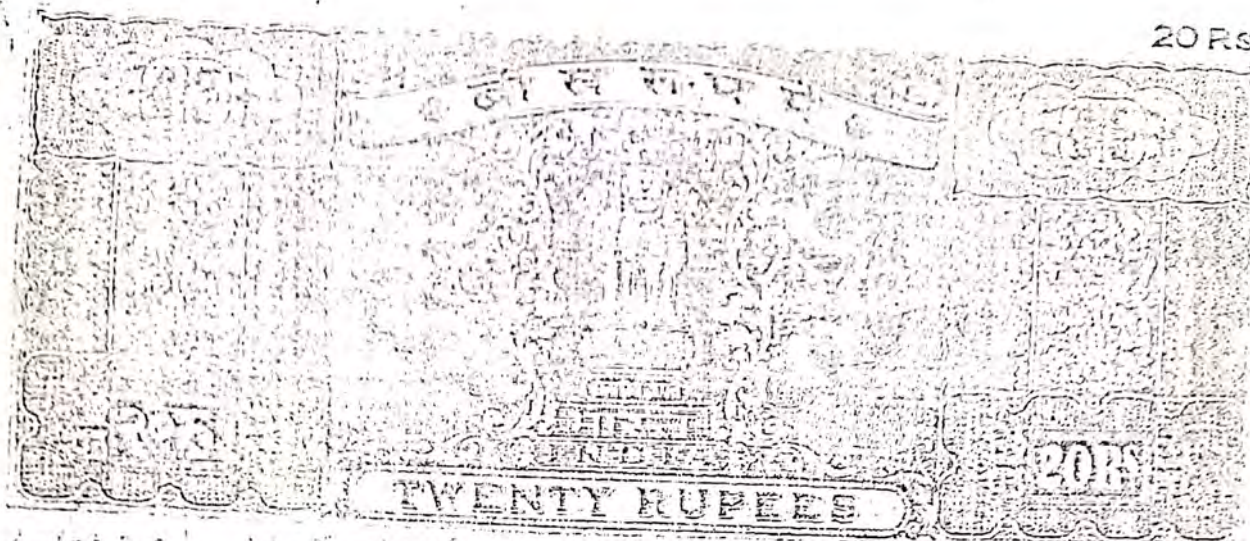




This memorandum of Association executed on this 11th June, 1984.

I. NAME OF THE ASSOCIATION:

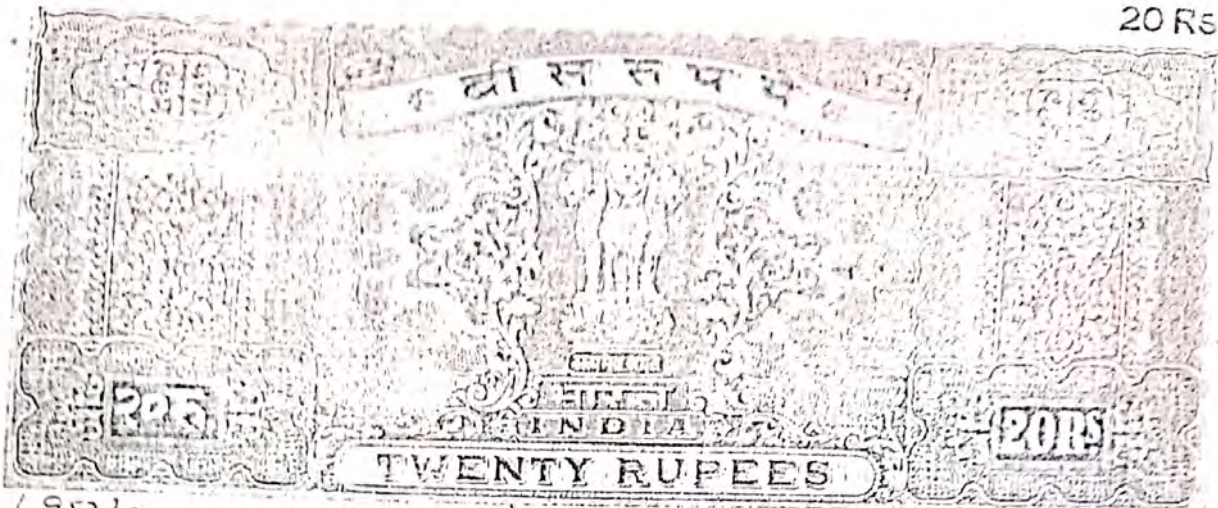
